Background Information

This national Summit will focus on assessment and accountability and is intended to provide technical assistance for state and local education leaders by:

- Identifying technology tools and resources that are available to support the accountability, student information, and data requirements of *No Child Left Behind*
- Demonstrating how to use data and decision making to achieve the requirements and intent of *No Child Left Behind*
- Promoting state collaboration on joint development or procurement of system components
- Promoting initiatives such as PBDMI and Schools Information Partnership (SIP)
- Illustrating how online assessments can inform instruction at the classroom level (e.g., diagnostic tests, real-time reporting, performance-based)
- Focusing on strategies to make assessment results useful
- Exploring opportunities for multi-state consortia to foster collaboration on the development of policies to move toward a system for computer-based assessment



- Promoting the benefits of online assessment with implementing *No Child Left Behind* requirements
- Demonstrating how online assessments can improve and strengthen state assessments
- Providing guidance on how a state can implement an online assessment statewide
- Exploring next generation assessment tools for math and science.
